MULTI-FACETED SCHOLARSHIPS FOR STUDENTS 2020-21

MULTI-FACETED SCHOLARSHIP INITIATIVES (2020 -2021)

(Approved in the 19th meeting of BoG held on 21st July 2020)

The Institute offers a diverse range of scholarship initiatives aimed at supporting academic excellence, financial need, and holistic student development. All the scholarships shown below are designed to recognize merit, encourage talent, and provide financial support, thereby promoting an inclusive and conducive learning environment for students from diverse backgrounds. This scholarship policy was reviewed.

ACADEMIC ACHIEVEMENT/MERIT SCHOLARSHIP

Only 15 seats to be filled on the basis of Institute's scholarship as per the following:

Branch: ME/EC/CE/IT/CM

Eligibility: On the basis of percentage in 12th:

- (a) Above 80%:-25% one -time fees relaxation (Rs. 77000/-) i.e. Rs.19250/-
- (b) 76% to 80%:- 20% one -time fees relaxation Rs. 15400/-
- (c) 71% to 75%:- 15% one -time fees relaxation Rs. 11550/-
- (d) 65% and above both in 10th &12th one -time fees relaxation Rs. 11,550/-

This scholarship is application-based, meaning eligible students must submit an application to be considered. The scholarship is intended to recognize and reward academic excellence at the pre-university level, providing financial support to help alleviate tuition cost.

ADVANCE REGISTRATION/EARLY BIRD SCHOLARSHIP

Under early bird scheme only 15 seats may be reserved for those who submit their entire fees before DTE counseling. The scheme will benefit the candidate on first come first serve basis. A one-time relaxation of Rs 10000/- may be given to the candidates of this scheme. This scheme is applicable for B. Tech (ME/EC/CE/IT/CM), MBA & MCA courses.

BEREAVEMENT ASSISTANCE SCHOLARSHIP (Socio-Economic Scholarship)

In the event of the death of a primary earning family member during a student's tenure, the student is eligible for a scholarship covering 50% of tuition fees for the rest of the course, upon submission of the necessary documentation.

COMMUTE SUPPORT SCHOLARSHIP

(AVAILABLE IN ACADEMIC SESSION 2019-20 AND 2020-21)

Students who secured First Division in the previous academic year were entitled to the Commute Support Scholarship for the current academic year. This scholarship was also available to students of economically weaker sections. This scholarship is awarded to all courses B.Tech, MBA & MCA. This scholarship has been discontinued from the year July 2021.

SC/ST/OBC & SOCIO-ECONOMIC SCHOLARSHIP

This scholarship supports students from SC/ST/OBC categories as well as those from economically weaker sections (EWS) based on socio-economic conditions. It ensures inclusivity and equal opportunities by reducing financial burden and promoting higher education among underrepresented groups.

ITM COMMUNITY SCHOLARSHIP

The wards or relatives of ITM employees, alumni, vendors, and long-term associates are eligible for the ITM Community Scholarship. This scholarship honours those connected to the ITM community and ensures they have access to quality education. It covers tuition and associated fees, reflecting ITM's commitment to supporting its extended family. The Scholarship is a testament to ITM's commitment to its community, fostering a supportive and inclusive environment for all.

Students are required to submit a formal application, along with the relevant documents for consideration of their request. ITM is committed to supporting its students through these various scholarships, ensuring that financial barriers do not hinder their educational aspirations.

Students who are economically weak will get benefitted under this scholarship.

TUITION FEE WAIVER (TFW) SCHEME

The Tuition Fee Waiver (TFW) scheme offers financial aid to students by waiving their tuition fees. Available in Madhya Pradesh and other states, the scheme includes the following key features:

Eligibility: Open to students from all categories (GEN/OBC/SC/ST) and regions. To qualify, students must be children of parents with an annual income below a specified threshold, typically around Rs. 8 lakh.

Fees: The waiver applies only to tuition fees, while students are responsible for covering all other associated costs.

Admission Process: Admissions are conducted via centralized counseling, following the same procedure as regular admissions.

Course Restrictions: Once admitted under the scheme, students cannot change their course, branch, or discipline.

Note: A student can only receive the benefits of one scholarship at a time.
