The HOD initiates the audit process by leading a detailed review of all academic activities undertaken during the past semester. This includes:

- **Course Delivery:** A discussion on the effectiveness of teaching methods, including traditional lectures, blended learning, and any innovative pedagogies implemented. Feedback from students, faculty, and course coordinators is reviewed to assess how well course objectives were met.
- **Curriculum Implementation:** The department reviews the implementation of the curriculum as per the approved syllabus. This includes assessing whether all topics were covered within the specified timelines and if any modifications or adjustments were made to address emerging trends or student needs.
- **Assessment and Evaluation:** The outcomes of internal and external assessments, such as midterms, assignments, ABACAs, Quiz, Practical, projects, and final exams, are reviewed. The discussion also focuses on the fairness, transparency, and consistency of assessment practices.
- **Student Performance:** A thorough analysis of student performance across different courses is conducted. This includes reviewing the pass/fail rates, distribution of grades, student feedback, and any significant academic achievements or areas of concern.
- **Faculty Contributions:** The meeting evaluates the teaching effectiveness of each faculty member, including their engagement with students, innovation in teaching methods, and participation in departmental activities such as seminars, workshops, or research.

Finally, the department prepares a comprehensive report summarizing the outcomes of the end-sem. academic audit meeting. This report includes:

- A summary of the academic activities reviewed and the key findings.
- The identification of strengths and areas for improvement.


- A detailed action plan for addressing issues and implementing improvements in the next academic session.
