To achieve this, the Internal Quality Assurance Cell (IQAC) undertakes the Academic and Administrative Audit (AAA) annually, which is a comprehensive and systematic process involving both internal and external evaluations. The AAA serves as a peer review procedure designed to assess and monitor the institution's academic and administrative practices across multiple dimensions, ensuring that they meet both institutional standards and external benchmarks.

The AAA is an essential tool for maintaining accountability, enhancing transparency, and fostering a culture of continuous improvement within ITM. The process involves detailed assessments of the institution's academic programs, administrative systems, and overall infrastructure. These evaluations not only highlight areas of strength but also pinpoint opportunities for growth and improvement.

Objectives:

The main objectives of the AAA are as follows:

- 1. Assess Quality Standards and Processes: The audit encourages each department, as well as the institution as a whole, to assess their existing quality standards and processes in relation to established benchmarks, whether academic, administrative, or infrastructural. This ensures that ITM's operations are aligned with its mission, vision & values.
- 2. Identify Areas for Improvement: Through comprehensive internal and external reviews, the audit aims to identify potential areas for improvement in both academic and administrative functions. It provides a constructive platform for departments and administrative units to reflect on their practices, recognize challenges, and take steps toward solutions.



- 3. Provide Recommendations for Continuous Enhancement: The AAA process results in actionable recommendations that help the institution to continually enhance its systems, both academic and administrative. These recommendations cover a broad spectrum of activities, from teaching practices to administrative efficiency and resource management.
- 4. Ensure Accountability and Transparency: The audit ensures that the institution maintains transparency in its operations and upholds the highest standards of academic and administrative practices. It fosters a sense of accountability across all levels of the institution, ensuring that all processes are clearly defined, monitored, and evaluated.

Components of the AAA

The AAA at ITM includes two key components: Academic Audit and Administrative Audit. Each component is designed to evaluate specific aspects of the institution's operations and provide insights into their effectiveness.

1. Academic Audit

The academic audit focuses on the assessment of ITM's academic programs, teaching-learning processes, student outcomes, and research activities. Key areas of focus within the academic audit include:

- Assessment of Curriculum Delivery Process: Academic audit monitors the strategies, resources, and teaching practices used by faculty members to ensure that the learning objectives of each course and program are effectively met. In an academic audit, evaluating curriculum delivery is a critical component because it directly impacts the quality of education and the learning outcomes of students.
- Faculty Performance and Development: Reviewing the qualifications, teaching effectiveness, and professional development of faculty members. The audit examines whether faculty members engage in continuous learning
- and are supported with development opportunities to enhance their teaching skills.



- Student Learning Outcomes: Assessing how effectively the academic programs help students achieve the intended learning outcomes. This includes reviewing assessment methods, student performance, and post-graduation success rates.
- Research and Innovation: Evaluating the quality and impact of research conducted at ITM, including faculty research, student research opportunities, and institutional support for innovation.
- Extracurricular Activities: Analysing the contribution of extracurricular activities in enhancing the holistic development of students and supporting the academic experience.

2. Administrative Audit

The administrative audit examines the effectiveness of ITM's administrative processes, focusing on how well they support academic and institutional goals. Key areas of evaluation within the administrative audit include:

- Infrastructure and Support Services: Reviewing the adequacy of physical infrastructure, including laboratories, libraries, classrooms and other campus facilities.
- Governance and Leadership: Assessing the effectiveness of the governance structure, leadership practices, and decision-making processes at ITM. This includes evaluating whether the institution's policies and strategies align with its long-term goals.
- Resource Management and Utilization: Evaluating the institution's management of both human and financial resources. The audit reviews how resources are allocated, managed, and used to support academic and operational objectives.

Process for Conducting Academic and Administrative audit (AAA):

An annual Academic and Administrative Audit (AAA) is conducted by each department at the end of the academic year. The Academic and Administrative Audit (AAA) team consists of internal members, along with an external member who is a senior academic professional from the relevant faculty.



The audit panel takes note of all the findings. Members deliberate about their findings and reach a conclusion that accurately represents the present situation at the concerned department. The audit process involves a comprehensive review of the departmental academic and administrative operations. During the audit, the team carefully examines all relevant findings, with each member contributing their insights based on their respective areas of expertise. The team engages in detailed deliberations to assess the effectiveness of current practices and identify areas for improvement. Through collaborative discussions, the members work together to ensure that the conclusions drawn accurately reflect the present situation within the concerned department. This thorough evaluation process ensures that the final report provides a clear, balanced, and well-rounded representation of the department's performance, highlighting strengths and pinpointing opportunities for enhancement.

Outcomes of Academic and Administrative audit (AAA):

Upon completion of the Academic and Administrative Audit, the following outcomes are expected:

- Comprehensive Evaluation Report: A detailed report that summarizes the findings of both the academic and administrative audits. This report includes an analysis of strengths, weaknesses, opportunities for improvement, and recommendations for future actions.
- Actionable Recommendations: Clear, actionable recommendations to address identified areas of improvement in curriculum delivery, faculty development, administrative processes, resource management, and infrastructure.
- 3. **Strategic Planning for Improvement:** The findings from the audit will inform the institution's strategic planning process, ensuring that the necessary steps are taken to enhance both academic and administrative functions.
- 4. Monitoring and Review: The institution will implement a monitoring system to track the progress of the recommendations and improvements identified during the AAA. This ensures that the outcomes of the audit are translated into real, measurable improvements.
