This has reference to Appeal dated 25-06-2022 filed by Institute of Technology and Management Gwalior, ITM Group of Institution Campus, Opposite Sithouli Railway Station, NH-75, Jhansi Road, Gwalior- 475001, Madhya Pradesh against the decision of NBA for not granting accreditation to Masters in Business Administration program of your Institution, communicated vide NBA's letter of even number dated 22-02-2023.

2. The Appeal was considered by the Appellate Committee of NBA in its meeting held on 02nd March, 2023. The recommendation of the Appellate Committee was considered by the Competent Authority in NBA. Based on the decision taken, accreditation status of the program is given in the table below:

2. The Appeal was considered by the Appellate Committee of NBA in its meeting held on 17-08-2022. The recommendation of the Appellate Committee was considered by the Competent Authority in NBA. Based on the decision taken, accreditation status of the following program is given in the table below:
